I understand this is a onetime affidavit affecting me at any and all gatherings of The Thunder River Renegades, Inc.

I understand that all ammunition must be loaded to SASS (Single Action Shooting Society) specifications with lead only bullets and that all participants and spectators must wear hearing and eye protection while firearms are in use. I understand that unsafe behavior, improper use of firearms, failure to obey safety instructions, use of alcohol or drugs (illegal or performance hampering), or failure to respond to any safety command will result in immediate disqualification from the match and eviction from the range. I also understand that I assume responsibility for the actions of any minors or guests that I sponsor.
